When submitting the application form to AmCham SL, please include:

- Two Passport size photographs (digital version of minimum 300 dpi);
- A letter of recommendation by an existing AmCham SL member;
- A Certified True Copy of the Business Registration Certificate;
- A brief summary description of your organisation's main activities;
- A Certified True Copy of the previous year's audited accounts (or past quarter, in the event of a newly formed company - where applicable); and
- A letter from the Company Secretary validating the current US Equity Investment (not required for Affiliate Membership).

The American Chamber of Commerce in Sri Lanka does not discriminate against any companies or individuals based on race, gender, color, creed or religious background. The information provided will be passed to the US Embassy in Sri Lanka for review and will be held in the strictest confidence.

AmCham SL Membership Categories - Eligibility Criteria

Corporate Full Member: Partnerships, firms, companies, corporations, representative/liason offices or other organisations of associations with American equity participation of a minimum of 15% and which are registered in Sri Lanka and currently operating in Sri Lanka as independent entities or engaged in joint ventures. Government representatives of the USA in Sri Lanka as designated by the US Ambassador in Sri Lanka and citizens of the United States residing in Sri Lanka.

Affiliate Member: Partnerships, firms, companies, corporations, representatives/liason offices or other organisations or associations that have actual American business interests, such as representatives of companies in Sri Lanka or of companies other business or commercial entities in the USA engaged in import and/or export of goods and services to and from the USA.

Probationary Member:

All AmCham SL applicants will meet with the AmCham Membership Committee. The Membership Committee will review the application, meet with the applicant and make recommendations for approval to the Board of Directors. On obtaining approval of the Board of Directors, an applicant shall be granted the status of membership.

Membership Fees

Membership subscriptions are pro-rated from the time you join, up to the end of the current financial year as applicable and will have to be paid in advance at the time of submission of the application.
